### Concessions

Once you have purchased your membership you will need to take your proof of identification to the leisure centre of your choice.

#### Students studying full time (Schools, Further Education, College or University).

Available to students studying or living in Wolverhampton, (students who study out of the borough and live out of the borough DO NOT qualify for concessionary rate.

#### Proof of studying or living in Wolverhampton.

- Personal identification – Utility bill (dated within the last three months), driving license etc, which must contain address.
- If you are aged 16+ you must provide a letter from your place of education as proof that you are a student for any subsequent academic year (1st September – 31st August), you must provide updated proof at the beginning of each academic year. NUS card must include an expiry date.

#### In receipt of Benefit

If you are in receipt of a means-tested benefit (e.g. income-based JSA, income-related ESA (Incapacity benefit), income support, working tax credit and/or full housing benefit, child tax credit Universal Credit (new benefit name).

#### Proof of benefit

- Must be a Wolverhampton resident to get this concession. Housing benefit letter is required as proof.

- Appropriate proof of benefit you receive which identifies you by name and address / personal identification – (council tax bill to confirm you are a council tax payer to Wolverhampton)
- Entitlement letter or award notice with your utility bill with your current address on (dated within the last 3 months).

#### If you are aged 60+ and a resident of Wolverhampton Proof of 60+

Two proofs of ID Required: Council tax bill and proof of date of birth - passport/birth certificate/driving licence
